If within that time period a lesser number of bids have been obtained that we will then move forward with the best provided. Director Dave Hubbert amended the motion to obtain 2 bids for \$20,000-\$50,000 significant expenditures and 3 bids for \$50,000 plus for significant expenditures. Vice President Robin Mitchel seconded the amended motion. The motion passed unanimously.

Treasurer Joe Caso motioned to accept the revised proposal from the Finance Committee to table the paving of Golf Club Drive from Kestral to the Sanctuary gate to 2021. Vice President Robin Mitchel Seconded. Motion passed unanimously.

Director Dave Hubbert motioned to approve the budget for the Fitness Center remodel for \$54,048.98. Treasurer Joe Caso seconded. The motion passed unanimously.

President Bill Buzzi motioned to approve the ordering of new speed limit signs and poles from Foresite for \$5,633.70 to get the HOA in compliance with DOT standards in order to write citation for violators of the 15mph speed limit rule. Secretary Mike Wilbur seconded. The motion passed unanimously.
