Treasurer's Report:

The delinquencies and foreclosure actions reported in the monthly collection report. Delinquencies in March were the same as February approximately 17k.

- We have a net income loss of \$25k YTD due to insurance payments at the beginning of the year that were budgeted for end of the year
- Landscaping is still under budget
- Security is over budget by 22k due to extra pay periods and Quickpass gate expenses
- Utilities are over budget in the first 3 months but are expected to come down and balance out

6. REPORTS OF COMMITTEES

ARC Committee- Meeting has been rescheduled until May 3rd.

P&S Committee- Meeting was 4/10/23 Voted on new stickers that will arrive end of this week.

Finance Committee- They will be scheduling an early meeting this year after Labor Day. Discussion of using reserve funds owners have until May 15th to vote.

L&M Committee- No Meeting -

- Chairperson Nancy Hubbert stated they are continuing to assess plans for Kingfisher as they may get points for the Mahogany tree that owner had removed.
- Plants at the front entrance will remain as they are making a comeback.
- Randy and Nancy are meeting at Mama's Garden Center to get suggestions and cost for the Kingfisher project.
- The party at the pool on March 25th was a success, the next one is planned for November.

Cable Transition Committee – Dave Hubbert mentioned CSI has provided 3 quotes between the ranges of \$63-\$80 per month and they are currently working on a survey. Truman Annex went with Hotwire and so far, no complaints.
